THE DISTRICT

Rancho Water is a local, independent Special District organized on August 16, 1965, operating pursuant to the California Water District Law, Division 13 of the California Water Code. From its inception, Rancho Water has planned for and met the ever-changing water needs of the growing and diverse community it serves in an economical and sustainable manner.

Today, Rancho Water supports over \$1.3 billion in economic activity. Because conserving and managing the area's unique water resources are essential to the continued viability of the community, Rancho Water is actively involved in efforts to address imported water supply availability, system capacity constraints, rising imported water costs, water quality issues, and recycled water.

The District is governed by a seven-member Board of Directors that is responsible for setting policy and decision making. The General Manager supports the Board of Directors and provides executive oversight of day-to-day activities, including a \$140 million operating and non-operating budget and 164 full-time employees. Legally a "political subdivision of the state," Rancho Water operates in an open and public environment. The District's responsible fiscal management and planning provide the financial means to ensure reliable water and wastewater system operations. Rancho Water's 2023 Strategic Plan is a blueprint for how the District will respond to current challenges and make the best of future opportunities for the benefit of its customers.

THE POSITION

The Assistant General Manager - Engineering and Operations is a key leadership role within Rancho California Water District (Rancho Water/District) responsible for overseeing the Engineering, Operations, and Maintenance functions within the District. This position plays a crucial role in ensuring the reliable and efficient delivery of clean and safe water, wastewater, and recycled water services to the community while adhering to all regulatory and environmental standards. The Assistant General Manager – Engineering and Operations will collaborate closely with the General Manager, department heads, and the Board of Directors to achieve the District's goals



and objectives. This person will represent the District in interagency projects and programs, industry activities, and securing external funding, and will participate in regulatory and policy discussions and activities.

The Assistant General Manager – Engineering and Operations will be responsible for providing strategic direction and leadership to the engineering department, overseeing the planning, design, and construction of water, wastewater, and recycled water infrastructure projects, while ensuring compliance with industry standards and regulatory requirements. Responsibilities also include the direct supervision and coordination of day-to-day operations of the water treatment, wastewater treatment, and recycled water facilities and distribution operations, along with the management of water quality, quantity, and system performance. The Assistant General Manager - Engineering and Operations will collaborate with the maintenance and operations teams to optimize system performance and will be responsible for staying current with federal, state, and local regulations related to water quality distribution and wastewater system operations. The role will be responsible for developing and managing the departmental budget, including capital and operational expenses, and identifying opportunities for cost savings and efficiency improvements.

QUALIFYING EDUCATION AND EXPERIENCE

The appropriate knowledge, skills, and abilities can be achieved through a variety of combinations of experience and training. A typical example is: Equivalent to Bachelor's Degree in Civil or Environmental Engineering, Engineering Management, or Public or Business Administration. Requires a minimum of ten (10) years of experience with increasingly senior management responsibility in which three (3) to five (5) years should be in the water, wastewater and/or utility industry. At least five (5) years of this experience should be supervisory in nature. A Master's Degree is highly desirable.

COMPENSATION & BENEFITS

SALARY: \$199,000 - \$259,000 DOQ. In recognition of the value they bring to the District, Rancho Water provides eligible employees the opportunity to participate in various employee benefits. A few of those benefits are listed below:

CALPERS RETIREMENT: The District participates in the CalPERS pension system. Benefits are 2.7% @ 55 for employees hired on or before December 31, 2012, (Classic) and 2% @ 62 for employees hired on or after January 1, 2013, (PEPRA).

MEDICAL INSURANCE: Coverage is available for eligible employees and their dependents. Coverage may be waived with proof of other health insurance.

DENTAL AND VISION INSURANCE:

Coverage is available for eligible employees and their dependents.

FLEXIBLE SPENDING ACCOUNT (FSA): Optional benefit for eligible

(FSA): Optional benefit for eligible employees.

LIFE INSURANCE: The District provides eligible employees Group Insurance at twice their annual salary, capped at a maximum of \$375,000 no cost to the employee.

INSURANCE: The District participates in California's State Disability Insurance (SDI) program.

RETIREES: The District provides a retiree benefit plan that includes medical, dental, and life insurance with premium costs shared between the District and employee.

EMPLOYEE ASSISTANCE PLAN (EAP):

All District employees are eligible to obtain confidential counseling as well as other work life benefits through EAP.

SUPPLEMENTAL BENEFITS: The

District offers supplemental benefits to eligible employees at their expense.

VACATION: Eligible employees may accrue vacation hours beginning on their first day of employment. Exempt employees begin accruing 4.62 hours per pay period effective their first day of employment or promotion.

SICK LEAVE: Eligible employees may accrue sick hours beginning on their first day of employment at the accrual rate of 3.69 hours per pay period.

HOLIDAYS: The District observes ten federal holidays. Eligible employees also receive one floating holiday per year.

EDUCATION ASSISTANCE: Available for all regular full-time employees who have been employed by the District for a minimum of 1 year and who have maintained a satisfactory performance rating.

CERTIFICATE BONUS AWARD:

Employees may be eligible to receive a one-time bonus if they have completed a course or program and received a new certification or degree.



INNOVATING FOR THE FUTURE







Groundwater Banking Expansion Program

- Maximizes the groundwater that can be recharged via ponds and recovery wells
- Unique "in-region" project that addresses resiliency for droughts and emergency events by providing enough water for 300,000 homes
- Allows recharged groundwater to become the primary water source in the service area, minimizing the need for treated imported water
- Keeps water affordable for southwest Riverside County
- Water treated and delivered from three additional sources
 local groundwater, Vail Lake, and Lake Skinner

Cost: Phase 1 - \$100 million

(\$14 million awarded in state and federal funding)

Vail Dam Seismic & Hydrologic Remediation Project

- Dam provides approximately 40,000 AF of above-ground water storage
- Water can be released for storage in the groundwater basin at a current recharge rate of 27.4 CFS or 20,000 AF and 40,000 AF with upcoming future facilities
- Provides water supply and downstream safety benefits through dam seismic retrofitting
- Project includes replacing the existing concrete arch portion of the dam with a roller-compacted concrete dam 6' higher and 400 feet wider than current dam

Cost: \$110 million

(\$50 million awarded in FEMA funding)

Small Hydroelectric Energy Management Program

- As part of Rancho Water's commitment to reduce peak energy demands, installation will provide a permanent offset of annual energy use
- Reduces energy by over 2.3 million kilowatt hours
- Provides annual energy cost savings of \$300,000

Cost: \$3.5 million

(Funded by a grant from Riverside County)

Rancho Water's CropSWAP program

replaced 160 acres to date of high-water-use crops with low-water-use varietals such as wine grapes, cut flowers, and citrus. The program has received \$9 million in funding to expand into Riverside and San Diego Counties.
